WHEREAS, members of the community and other persons present consider Board Member Patricia Martinez-Roach's statements and conduct to be

inappropriate, disrespectful, hateful and offensive to members of the East Side community; and

WHEREAS, the Board of Trustees finds that Board Member Patricia Martinez-Roach statements and actions were not consistent with the spirit or words of Board Bylaw 9005 or the District's core values and are a poor example to the students of this District on positive, effective and responsible leadership.

THEREFORE BE IT RESOLVED, that the Board of Trustees hereby censures Board Member Patricia Martinez-Roach for her inappropriate conduct at the May 25, 2006, Board Meeting, and directs that a copy of the September 22, 2006 Independent Investigation Report prepared by Hanson, Bridgett, Marcus, Vlahos & Rudy LLP and a copy of this Resolution shall be placed immediately on the District's website for a period of 45 calendar days.
