8.1 Approve Variable Term Waiver Requests for Certificated Employees

8.2 Approve 2004-2005 Budget Reductions Proposal

The proposal has been amended to include an increased dollar amount to be taken from supplies to offset the budget and to add another full-time position where the Principals will make the determination as to how they will combine it into one position as two .5 or half-time positions.

The proposal includes the reassignment of 12 teachers on special assignment; release of four classified managers; reduction of library services by 50%; reduction of counselor services by 10.0 FTEs; reduction of classified employees by 1 employee (1.0 FTE) per site, which will be decided by the site Principal; general fund budget reductions by an estimated \$950,000; reduction of Child Nutrition Services budget by \$120,000 as a result of giving notice to Sodexho to eliminate their contract; estimated \$125,000 energy savings; savings from the general fund due to a Resolution regarding the Director of Transportation, Director of General Services, Energy Manager, Director of Insurance & Risk Management; and the reduction of general fund legal services.
