8.4 Report on Status of Quimby Land Sale Proceeds

Legal Counsel indicated that in or around 1969, the District acquired approximately 55 acres on Quimby Road. The land was originally acquired for \$700,000 with a loan from the State, which was repaid by the District in full. The repayment was with general fund monies. In the early to mid 1970's the property was exchanged for a larger parcel, approximately 61 acres across the street. The exchange took place with a residential real estate developer. As a result of the exchange, the District acquired an additional six or more acres through that exchange for no additional money paid out of the District. Evergreen Valley High School was built on approximately 48 acres of that land. After the subdivision to allow for the high school, it left a residual of approximately 13 acres. In the 2002 timeframe the Governing Board for the District determined that property to be surplus and authorized the property to be sold.

The property was sold in 2003 for \$12.1 million. The reason it was mentioned that the property was determined as surplus property is because it has a legal significance under the Education Code. Specifically, the Education Code states that funds derived from the sale of surplus property shall be used for essentially for capital outlay purposes and not for general fund purposes, except and unless the Board makes certain determination regarding capital needs over the next five years. It cannot do that without the prior consent of the State Allocation Board in Sacramento. Once the transaction closed escrow, approximately \$3.1 million was spent for general fund purposes without the prior approval or consent of the State Allocation Board. Under the Education Code it states that if a District sells surplus property then the funds derived from that sale have to be used for capital outlay. The Education Code doesn't make any exception for the source of funds. Earlier this week the Board received a letter from former ESUHSD Superintendent Frank Fiscalini. Mr. Fiscalini was the Superintendent of the District at the time the District acquired the Quimby Land and also at the time the District exchange the original parcel for the larger 61 acre parcel, Mr. Fiscalini's letter brings to this issue his explanation as to the intent of the District in acquiring the property in the 1960's and the intent in exchanging the property in the mid 1970's for the larger 61 acre parcel. Mr. Fiscalini states that the larger parcel with the excess land, when the District acquired the lands they knew at the time they would never need all 55 or 61 acres for a high school, but that nevertheless the District purchased a parcel as an investment vehicle. So that at some point in time in the future if, and when, the high school was built, any excess residual land could be sold off and the District could reap the benefits of its investment. Mr. Fiscalini also makes the same statement with regard to the District's intent in exchanging the property for the larger parcel in the mid 1970's. The Education Code, on its face does not make any exception or take into account the intent of the District in acquiring the property in the first instance. At the present time, knowing that the Board of Trustees declared the property to be surplus in or around 2002, then the use of proceeds from the sale of those 13 acres is restricted by Education Code section 17462. From a legal standpoint, the issues that need to be explored as a result of Mr. Fiscalini's letter is whether or not the District's archives support Mr. Fiscalini's recollection of the intent of the District in acquiring the property in the first instance assuming that the District's

archive records do report that. The second issue would be can the Education Code support an interpretation that would allow for something called investment property and not surplus property. The third question raised is whether or not the Board in 2002 hadn't know those fact, hadn't known that analysis, would have avoided declaring the property surplus and, therefore, subject to the Restrictions of the Education Code and whether or not instead it would have chosen to treat the property and proceeds as a investment. The remaining legal issue would be, even if that was the case can this current Board rescind the prior action of the 2002 Board and now declare that property to be non-surplus and, therefore, free-up the monies for general fund purposes. Since the District is in a negative interim report state at this time, and given the Santa Clara County Office of Education's oversight responsibilities of the District, before any such action took place, it would be prudent, that the County Office of Education be given an offer of proof, be given the explanation and theory under those funds can be used. The District is pursuing a special legislation to the California legislation that would allow the District to use those funds for general fund purposes.

Member Mann went on record to say that he will not be supporting any financials risks. He will support special legislation.

Cathy Grovenburg, Assistant Superintendent of the Santa Clara County Office of Education, stated that the County will support the Education Code. Under AB1200 it is their responsibility to ensure that the District is complying with Education Code. The information that they would need to see in order to support the transaction is the documentation, which validates the fact that either the land was purchased with general funds or whatever Legal Counsel requires and that it was not surplus property. Also needed is documentation on the four points listed by the District's Legal Counsel. She will still need to speak with her Superintendent and Legal Counsel.
