MetroED:

Their First Interim Report was passed last night with a positive certification. The Campbell High School District is considering dropping out of the Adult Education Program. At their meeting in December, they did consider it, but they did not take action at their meeting. Los Gatos is considering dropping out of the MetroED Program for the CCOC. They only have eight to ten students in the program. It wouldn't create a significant burden on the program if they were to drop out. The same is true of Campbell. It only affects the adult education side. The question would be is if Campbell dropped out of the adult education side, would San Jose Unified decide to do the same. That is something that I will have to monitor next year.

I have two reports to file with the Board as part of the record of my activities. The CSBA Delegate Assembly meeting that is just written – you can put that in the record. I also have a report on my activities at the conference. I am just asking that it be placed into the record.

Lan Nguyen, Vice President

I support what Madam Clerk said earlier about having a budget study session so that all stakeholders can participate because I know we have to submit another Interim Report in March. We need to start talking about it in January, if not early, probably mid January so that community members and stakeholders can have an opportunity to provide input as far as our budget and look at our budget priorities.

A few weeks ago I ran into District Attorney Dolores Carr at a community function. She mentioned an issue that is important because it helps with the ADA generating issues. Apparently, there is a high truancy rate with students in our school district. Addressing the truancy problem would also help the ADA, but there's an issue of with working with DA's Office and sending letters out to truant students. By doing that, it will not only help us, but also get us additional revenue by sending out that letter. Anything that helps with the budget so that we don't have to trim programs or staff will be worth looking into. I hope that at our January or February meeting we can look at those things.

Patricia Martinez- Roach, Clerk

I have had very successful meetings with parents. I met with the Latino Parent Coalition, Vietnamese Parent Coalition and the African American Parent Coalition. I am also planning on meeting with PTA and School Site Council. As a result of all these meetings, some good things have come out. We are going to begin some training with the parents. Hopefully, all of it will be free of charge because parents want to be trained in safety issues and identifying symptoms for gangs. Not all the parents, but the majority requested it. I am very pleased to report that. Students continue to meet and they have requested as their priorities discussing alcohol and drug abuse. We are continuing to address that with the Student/Board Relations.
