## 1.02 Announcement and Public Comment regarding Items to be discussed in Closed Session (Government Code 54957.7)

President Frank Biehl extended a welcome to everyone, explained the format of the meeting, noted that all Board Meetings are recorded and offered the public to comment on item(s) to be discussed in Closed Session.

The following statement was entered into the record for an emergency amendment to the agenda:

On January 25, 2017, President Donald J. Trump signed an executive order titled "ENHANCING PUBLIC SAFETY IN THE INTERIOR OF THE UNITED STATES" that gives the President and his subordinate executive officers, including the Attorney General and the Secretary of Homeland Security, the power to declare any "sanctuary jurisdiction" ineligible to receive federal funds.

On February 3, 2017, the County of Santa Clara filed a lawsuit against the President and other officials for declaratory and injunctive relief from the Executive Order. If enforced, the Executive Order could harm undocumented students, their parents, and ultimately, the District community. On Wednesday, March 8, 2017, after the posting of the agenda for this Board meeting, the District was informed that the County has filed a motion for a preliminary injunction to stay the enforcement of the Executive Order and the withholding or conditioning of federal funds under the Executive Order, and that the court has ordered that any amicus curiae briefs in support of the County motion must be filed no later than March 22. The Orrick law firm in San Francisco has offered to prepare and file an amicus brief in the County lawsuit on behalf of the District and other school districts in the state on a pro bono basis (ie. at no cost to the District). Because of the court deadlines there is a need to consider and take immediate action on whether the Board should authorize the District to join in an amicus curiae brief to the court in support of the County's complaint and motion and to present information to the court regarding the impact of the Executive Order on schools.

Pursuant to section 54954.2(b)(2) of the Brown Act, the Administration and Legal Counsel are recommending that the Board consider this item in closed session as a matter of anticipated litigation under the Brown Act, and that the Board consider and take action on this item in open session as follows:

"Discussion and/or Action to Adopt Resolution 2016/2017-28 Approving The Filing Of A Legal Brief With Other School Districts As Amici Curiae In Support Of The County Of Santa Clara's Complaint Challenging The Executive Order Directing Reprisals Against Sanctuary Jurisdictions And Authorizing The Execution Of Necessary Documents And Related Actions"

Pursuant to the Brown Act, consideration of this matter by the Board in closed and open session as recommended requires an affirmative vote by two-thirds of the Board Members present, or a unanimous vote if not all 5 Board Members are present.
