5. BOARD OF TRUSTEES / SUPERINTENDENT - STUDY SESSION/WORKSHOP ITEMS FOR DISCUSSION ONLY

5.01 Presentation, and/or Discussion regarding the Development to International Baccalaureate (IB) Program at Andrew Hill High School - Glenn Vander Zee, Associate Superintendent of Educational Services, and Jose Hernandez, Principal, Andrew Hill High School

The presentation focused on the International Baccalaureate (IB) Program developments, the Middle Years IB Program, and the next steps to improve success for all students. The Program focuses on mastering transferable skills.

In the IB Program: (a) All staff and students know Approaches to Teaching & Approaches to Learning; (b) All students meet A-G requirements and take at least one IB test; (c) All students in IB Diploma Program obtain an IB Diploma.

Middle Years Program (MYP) Progress Update

- All 9th and 10th grade teachers attended an IB training
- All 9th and 10th grade courses will have 4 common unit lessons with assessments by the 2019-20 school year
- MYP utilizes the Cycle of Inquiry process to develop and analyze student work via a common unit lesson plan

IB Program Goals

- 1. Have Every Student Take One IB Course: School year 2017-18 reflects a total of 562 students taking at least 1 IB course.
- 2. Representative Participation in Diploma Program: School year 2017-18 reflects 69.3% Asian students and 26.6% Latino students participating in the IB Diploma Program while school enrollment data reflects a student body population comprised of 35% Asian and 58% Latino.

Next Steps

- Continue the financial support to meet the two IB goals listed above
- Continue use of Middle Years Program: 4 complete common unit lessons for each course
- Begin the process of collaboration with (2) feeder middle schools about MYP,
 Sylvandale Middle and Lairon Academy
- Additional supports for IB Diploma Program to increase student success via social emotional support and tutoring, including Stanford Science Mentors

- Addition of new IB Diploma courses:
 - o Spanish-language & Literature (heritage speakers)
 - o Math courses
 - o English as a Language Acquisition course
 - o Sports & Exercise Science

5.02 Presentation and/or Discussion regarding Preliminary Budget Development - Marcus Battle, Associate Superintendent of Business Services, and Silvia Pelayo, Director of Finance

The presentation on the Preliminary Budget included the State budget update, May forecasts, multi-year budget assumptions, scenarios and their impact, as well as next steps.

State Budget Update

- The Department of Finance has reported that State Revenues as of March 2018 are ahead of forecast by \$3.3 billion
- Many State budget experts believe the Department of Finance may not increase its forecast for 2018-19 General Fund Revenues by the full \$4 billion, which has accrued through April

Key Impacts from Governor's Budget Proposal 2018-19

- The Governor is proposing \$2.9 billion for the Local Control Funding Formula (LCFF), which represents full-funding of the LCFF initiative
- One-Time Discretionary Funding: The Governor is proposing \$1.8 billion in one-time discretionary funding.
 - o This is equivalent to \$295 per pupil or an estimated \$6.6 million for ESUHSD

May Revision Forecast

Latest Update: According to School Services, it appears that the level of funding proposed by the Governor in his January Budget will be close to the funding level contained in the May Revision. Due to the factors that drive Proposition 98 in the budget year, a big boost in education funding from the May Revision seems unlikely.

Fiscal Year 2018-19 Major Changes in Revenues

- Local Control Funding Formula (LCFF/Supplemental) \$4.9 million increase based on Governor's Budget
- Federal Revenues No change
- Other State \$6.6 million increase primarily from one-time discretionary funds \$295/ADA in 2018-19
- · Local \$2.6 million for one-time redevelopment funding

- Special Education and Other Contributions (\$2.7 million) Decrease to General Fund revenue primarily due to increased contributions for Special Education due to increased County Office of Education costs and increased contract services
- Transfer for Routine Restricted Maintenance (RRMA) Increase \$300K
