# Vice President Shirakawa

Embarrassed with the first draft. Felt not enough work was put into the policy proposal. He is not convinced there is a problem with Military Recruitment. Believes too much time is spent on this issue and believes there are other important issues that need to be addressed. Unless this policy proposal is "cleaned up", he will not support it.

#### Member Nguyen

This topic received a lot of negativity by the press. Member Nguyen indicate the district needs to find a middle road to make sure we are doing everything we can to protect our students, but at the same time, not deny access to services and information to our students. The proposal needs revisions. Not ready for a vote.

# President Herrera

The way the policy was presented, he did not believe it was ready for a vote. The policy needs more work. President Herrera indicated that research be done on what policies are for all career-orientated people. Wants the administration to come back with a standardized policy, and make sure No Child Left Behind is being implemented. He wants like the administration is communicating with our parents. Recommendation is to bring a revised draft back to the Board when the revisions are made on this policy.

#### Clerk Martinez-Roach

Needs clarification on proposed policy. She thanked speakers who expressed concern on the proposed policy. Reminded the Board this issue is about choice and privacy. Clerk Martinez-Roach indicated the proposal "Looks like a good template". She would like the proposal back with protocol on visitors on campus. Does not want military recruiters to mix with student on campus without parental permission. Parent should know when recruiters are on campus. ROTC "hardware" is allowed on Oak Grove campus. She would like for this to be explained on the "sunshine" draft. The policy needs to be included in other languages and to make sure parents understand the "Opt Out" provision. Parents need to know by signing this form, there may be impact on receiving information from other career/college organizations.

#### President Herrera

Sensed this policy will not have a majority vote right now. Standardize framework by any individual or organization offering a career path must sign in with school office. Policy for implementing our legal requirement for No Child Left Behind. The privacy right of parents need to be upheld. Administration asked to go back and

work on this policy. Asked Clerk Martinez-Roach and Member Mann were asked to work with administration in refining this policy. (Screening this policy before it return back to the Board for vote.) Clerk Martinez-Roach and President Herrera will work with administration on the policy and bring it back to the Board at a later date.

American Federation for Teachers, community, parents and students. He would like for the Board to consider California School Board Association to help with the search.

# Member Nguyen

Does not recommend spending too much money on the search. California School Board Association knows the process. At the end of the search last year, some individuals were not happy. A January timeline is good.

#### Vice President Shirakawa

California School Board Association is a creditable organization.

# President Herrera

The Board will start the process. The Board will use California School Board Association as a good medium/source for recruitment. Downside is a search will cost. Administration is requested to bring back the cost figures for using California School Board Association at the next meeting.
