#### 7) <u>STUDENT ACHIEVEMENT/BOARD DISCUSSION AND/OR ACTION</u>

A presentation was made by Andy Mam, ASB President, Evergreen Valley High School. Andy stated the ASB representatives at Evergreen Valley High School is a cohesive unit. Everyone on their team has something to contribute to the leadership. New class officer were

recently elected. Students completed their student planning and student calendar for the upcoming school year. Andy was on a team selected by Superintendent Nuñez to help with the appointment of the new Principal at Evergreen Valley High School. Andy commented on the hiring process, saying this was the first time students have ever been included and felt it was an important piece to the selection. Evergreen Valley High School would like to host the Student Leadership Conference in August.

#### 8) OPERATIONAL ITEMS/BOARD DISCUSSION AND/OR ACTION

8.1 Mt. Pleasant High School Presentation on Student Achievement Grettel Castro-Stanley, Principal, Mt. Pleasant High School

Grettel Castro-Stanley gave a brief snapshot of the successes at Mt. Pleasant High School.

#### Mt. Pleasant High School Successes

- ·Mt. Pleasant High school has the 2<sup>nd</sup> highest graduation rate in the district.
- ·85% students have passed the California High School Exit Exam
- ·60% students participate in Special Programs
- ·Successful AVID Program
- ·Excellent Student Leadership Program
- ·Mt. Pleasant has one of the safest schools in the district. This is because of the proactive approach to discipline. The latest safety report revealed a 72% reduction in student referrals
- ·Parents and community participation complete their family

#### Challenges

- ·Continue to close the achievement gap
- ·Need to connect 9<sup>th</sup> grade students to their academics
- ·Work with district to complete school modernization projects
- 8.2 Presentation on the Jose Valdes Institute Marla Bressani, Associate Principal, Andrew Hill High School

Marla Bressani made the presentation.

#### Mission

The goal of the Valdes Math Institute is for every student to take and succeed in first year Calculus before graduation from high school and to increase the number of under-represented students in these classes.

Students must be prepared for success in Algebra 1 upon entering high school. Students are recruited from the middle school in our feeder districts. Classes are offered to students who need one more class of advance math (Geometry, Algebra 2, Math Analysis/Trig) in order to reach Calculus by their senior year. Total enrollment is 921.

OPERATIONAL ITEMS/ BOARD DISCUSSION AND/OR ACTION

Funding – The district supports a coordinator. There is a memorandum of understanding with 4 feeder districts which allows the collection of ADA from those district to help fund the program.

#### Member Martinez-Roach

What is the eligibility for students to participate? What is the criteria for enrollment? We need to be more aggressive and let the feeder schools know why there is a charge for this program.

#### Marla Bressani

Students have to apply for the program. Student must take a test for placement.

#### Vice President Nguyen

I would like to thank Superintendent Nuñez for finding the funding from the 4 feeder schools to help support this program. (Berryessa School District did not agree to pay.)

#### Superintendent Nuñez

Thank you to the staff at Andrew Hill High School for supporting this program. We are looking forward to connecting with corporations to adopt this organization. We need to go out and find outside funding.

#### Clerk Mann

Excellent program. Mr. Pardo has preserved. Thank you Mr. Julio Pardo. Keep up the good work. You will have our support.

8.3 Public Hearing on Proposed 2006/2007 Budget: Report of Proposed General Fund Budget for 2006/2007 – Superintendent Bob Nuñez

Superintendent Nuñez stated we would not be holding a public hearing on this item. Next Thursday, June 22, we will have a work session. The work session will be held at 9:00 a.m. Presentations will be made by budget managers and Principals. Next Thursday, June 22, 6:30 p.m., there will be a Special Board Meeting addressing the Proposed 2006/2007 Budget.

## On June 29, 2006, the Public Hearing and Adoption on Proposed 2006/2007 Budget will be addressed.

A positive budget was presented for 2006/2007. It appears 85% of our funds will be supporting staffing. This budget was composed with help of the Principals and CSEA/ESTA representatives. We will present this to the County Office of Education on June 29, 2006.

#### Member Shirakawa

I would like to see some money go to training for staff. We will not be able to make the gains and improvements without training and having the highest paid staff.

8.4 ESTA Safety Report Survey - Superintendent Bob Nuñez, Don McKell, ESTA President

Report was presented by Don McKell, ESTA President. Information was taken from these surveys with concerns from each school. Don McKell suggested when staff is polled we should listen to what we hear. A new primary concern is school rules on truancy, cheating, and personal electronics not being enforced. A quarterly report will come to the Board indicating what the agendas are, who is attending, and how frequently the schools are holding their site safety reviews.

8.5 Quarterly Safety Report, Fourth Quarter 2005-2006 – Ric Abeyta, Assistant Superintendent of Student Services

This is the year end report. This report will give us the year end data. Quarterly reports from the sites have changed the environment at schools. We have done quite well this year. This is attributing to the safety teams at each school site and the Student Services Division. Staff members are contributing to supervision.

Ric Abeyta, Assistant Superintendent of Student Services shared a device that will be used on the inside of classroom doors that will keep the classroom door locked in case of an emergency.
