SUBJECT: Discussion and/or Action to Rescind/Revoke Certificated Personnel Action/Consent Item 19.02, Presented October 17, 2013, Purporting to Grant Permanent Status as it Pertains to One Current Certificated Employee

Pursuant to Education Code section 44929.21, a certificated employee who is employed by the District for two complete consecutive school years in a position requiring certification qualifications, and who is reelected for the next succeeding school year to a position requiring certification qualifications shall, at the commencement of the succeeding school year be classified as and become a permanent employee of the District.

At a regular meeting of the Governing Board held on October 17, 2013, the Board took action under Consent/Action Item 19.02 to grant permanent employment status to those certificated employees who met the criteria for attaining permanent status under Education Code section 44929.21. Due to a clerical error, certificated employee Robert Goldstein, who at that time had completed only one year of certificated employment with the District and who was, therefore, ineligible to attain permanent status, was inadvertently included among the list of those employees recommended for permanent status. As a result, the Agenda memo for Item 19.02 inadvertently included and identified Robert Goldstein as among the District certificated employees eligible to receive, and receiving, permanent employment status pursuant to section 44929.21.

The Board is requested to rescind its action taken on Consent/Action Item 19.02, on October 17, 2013, solely as it pertains to certificated employee Robert Goldstein, thereby clarifying Robert Goldstein's continued and continuous

Probationary 2 status.
