5. LCFF Update – Chris D. Funk, Superintendent

Superintendent Funk presented updated information regarding the Local Control Funding Formula (LCFF). It is going to take eight years and a total of \$12 billion to fully fund. The LCFF makes fundamental changes to how we allocate state Proposition 98 revenues to schools. At full implementation, the LCFF will fund every student at the same base rate.

The elements of the formula are:

- *Additional funding based on the demographics of the school district
 - *English learners*
 - *Pupils eligible for free and reduced-price meals program*
 - *Foster youth**
- *An unduplicated count
 - *The number of unduplicated pupils enrolled for each school district and charter school as a percentage of total enrollment**
- *A three-year rolling average of California Longitudinal Pupil Achievement Data System (CALPADS) reported counts
 - *2013-14 uses one year of data; 2014-15 uses the average of two years of data; 2015-16 and future years use three years of data**

6. Student Achievement Data - Chris D. Funk, Superintendent

Superintendent Funk presented information regarding African American student achievement results for 2012-2013. A copy of the presentation can be accessed on the District's website under AASA's web page.

7. Strategic Plan Update – Chris D. Funk, Superintendent

Superintendent Funk provided an update on the District's Strategic Plan. The first reading of the Strategic Plan will be presented to the Board of Trustees on November 14, 2013. The second reading will be presented to the Board of Trustees for adoption at the December 12, 2013.
