4. Summer Programs

Summer is very limited for 2011. This year, there is a collection of partners for summer schools. Summer school sites will be Andrew Hill, James Lick, Mt. Pleasant, Overfelt and Yerba Buena. Summer classes offered at various site (not all summer school sites) are:

- English & Biology through Gear Up
- Summer core classes through the Century 21 grant
- Silicon Valley Education Foundation is sponsoring Step Up to Biology, which will be offered to ninth grade students. This program is paid by Applied Materials.
- A-Learn is sponsoring math classes to students in the ninth grade
- Summer Bridge Program will offer classes in algebra
- Opportunity classes offered to at-risk students

The Adult Education Program will offer make-up courses to non-graduation seniors who need ten units to graduate. They must see their counselor to apply for make-up summer school classes in the Adult Education Program.

Recruitment for summer school will be at the school sites.
