The Superintendent will be developing long and short-term goals and plans to unveil his strategic plan in December 2013. At the October 2012 Board Meeting, the Superintendent be providing a report to the Board on his 90-Day Plan. The report will also be made available on the District's website.

Superintendent Funk will be reviewing fiscal finances, the opportunity gap and barriers that create the opportunity gap. He will develop and design a plan to support student achievement.

The Superintendent has changed the Governance Structure. They are:

- Board & Superintendent
- Superintendent's Council (direct reports)
- Cabinet (Principals; Directors; Association Presidents)

Cabinet will be part of the decision-making process with the Superintendent on matters to be taken to the Board for their consideration, specifically decisions that impact the site.

The Superintendent's goal is that every student leaves East Side Union High School District college and career ready.

At the September Board meeting, a laptop initiative will be presented to the Board of Trustees for their consideration. The initiative will provide teachers a new laptop with a roll out of the laptops occurring in January/February 2013. It is a four-year refresh program.

4. Early Alert System – Districtwide Implementation

Three sites volunteered to pilot an Early Alert System in 2011-2012: Andrew Hill, Oak Grove and Silver Creek. AASA would like parents to be notified after the first three weeks of the start of the grading period if a student is not doing well in class(es).

The high schools promote the use of School Loop with teachers, students and parents. Under review is the possibility to send out a TeleParent message to parents of a student who is not doing well in class. Also under review is the possibility of sending the message in different languages.
